**NOTICE OF POSTAL BALLOT**

Members are hereby informed that in terms of the provisions of Section 110 and other applicable provisions, if any, of the Companies Act, 2013, read with Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, the Company has on 22<sup>nd</sup> February, 2019, completed the dispatch of the Postal Ballot Notice dated 14<sup>th</sup> February, 2019 along with the Postal Ballot form:

- (a) through-email to Members (as on Friday, 15<sup>th</sup> February, 2019 being cut-off date) whose email addresses are registered in the records of depository participants viz. National Securities Depository Limited ("NSDL") and Central Depository Services (India) Limited ("CDSL") and with the Company's Registrar and Share Transfer Agent viz. M/s. Sharex Dynamic (India) Pvt. Ltd. and
- (b) through physical mode, along with a postage prepaid self addressed Business Reply Envelope to other Members (whose email addresses are not registered) for seeking approval of the members, in respect of business contained in the notice of the postal ballot dated 14.02.2019 by way of Postal Ballot/ E-voting.

The Company has provided e-voting facility to all the persons who are members of the Company as on cut-off date i.e. 15.02.2019 to enable them to cast their vote by electronic means. The Company has engaged the services of CDSL for providing remote e-voting facility to its Members.

The Board of Directors of the Company (the "Board") by resolution dated 14<sup>th</sup> February, 2019, has appointed Mrs. Ragini Chokshi of Ragini Chokshi & Co., Mumbai (COP No. 1436), as the Scrutinizer ("Scrutinizer") for conducting the postal ballot / remote e-voting process in a fair and transparent manner. All Members are, therefore, informed that:

1. Date of completion of dispatch of Notice of Postal Ballot is 22<sup>nd</sup> February, 2019.
2. The voting through Postal Ballot and remote e-voting shall commence on Sunday, 24<sup>th</sup> February, 2019 at 9.00 a.m. (IST) and shall end on Monday, 25<sup>th</sup> March, 2019 at 5.00p.m (IST). The remote e-voting module shall be disabled thereafter and not be allowed beyond 5.00p.m (IST) on Monday, 25<sup>th</sup> March, 2019.
3. The Postal ballot form, duly completed and signed by the Member(s) shall have to be returned in the prepaid self addressed Business Reply Envelope to the Scrutinizer so as to reach the Scrutinizer on or before 25<sup>th</sup> March, 2019 by 5.00 p.m. (IST). Any postal ballot form received after the said date shall be treated as if the reply from the Member(s) has not been received.

The duly filled in duplicated Postal Ballot Form should reach the Scrutinizer on or before 25<sup>th</sup> March, 2019 by 5.00 p.m. (IST).
5. A Member can opt for only one mode of voting i.e. Postal Ballot form or remote e-voting. If a Member casts vote by both the modes, then the votes casted through remote e-voting shall prevail.

- (b) that this Hon'ble Court be pleased to declare that the movable properties of the Defendant is validly hypothecated and charged in favour of the Plaintiffs as set out in Exhibit "C" annexed to the plaint and that the said charge is valid, legal, subsisting and enforceable;
