Spanish police raid HQ of PM Sanchez party

Barcelona: Spanish police searched the headquarters of the ruling Socialist Party on Wednesday in a probe into alleged financial wrongdoing linked to party member Lete Diaz, who allegedly tried to influence cops and legal cases that could damage the party.

New Hamas leader killed in Gaza

Deir Al-Balah (Gaza Strip): Israel carried out a pair of airstrikes in Gaza City late on Tuesday, killing at least three people and injuring 12, hospital officials said. The strike took place on the eve of Eid al-Adha.

120 Israeli airstrikes pound Lebanon

Tyre: Israel launched over 120 airstrikes across Lebanon in one of the heaviest bombardments in weeks. In PM Benjamin Netanyahu said the military was escalating operations against Hezbollah. A US-brokered ceasefire appears close to collapse, complicating efforts to end the war involving Iran, Israeli military said it struck 100 Hezbollah-linked sites in southern Lebanon and the Bekaa valley, including storage facilities, command centres and observation posts.

Iran releases 10 Indian sailors detained in '25

Tehran: Iran has released 10 Indian sailors detained on an oil tanker since July 2025 after "sustained diplomatic engagement". India's shipping authorities said. The sailors on board MV Harbour Phoenix were "detained, arrested and imprisoned in Iran following the vessels' interception near Jask Port in July 2025", the DG of Shipping said.

CHINA SUPPORTS PAK AS MEDIATOR

Beijing: China has officially stated its support for "active mediation" by Pakistan and other nations to address the ongoing West Asia conflict between the US and Iran. At a press briefing, Chinese Foreign Minister Wang Yi emphasized that negotiations between the two major parties are essential for progress.

Islamabad has previously dismissed reports alleging that it allowed Iranian military aircraft to use its airfields as "misleading".

Beijing asks Quad to stop meddling in maritime affairs in its neighbourhood

Beijing: China on Wednesday responded to the recent Quad Ministerial meeting by demanding the bloc stop meddling in maritime affairs in its neighbourhood. The Quad had previously voiced serious concerns regarding the situation in the East and South China Sea.

China claims most South China Sea, while facing counterclaims from regional nations. It maintains a maritime dispute with Japan over the Senkaku Islands, which China refers to as Diaoyu Islands.
