MONSOON MISERY: In Prayagraj, cremations shift to lanes as ghats submerged

Flood fury in UP: Villagers flee homes

Relentless rainfall and rising river levels have plunged parts of Uttar Pradesh into crisis, with the Ganga and Yamuna rivers surging dangerously in districts like Prayagraj and Varanasi. Low-lying areas have been swamped, thousands of families displaced, and even the sacred cremation rituals of the dead are now taking place in streets and alleys.

In Prayagraj, the floodwaters have engulfed riverbank colonies, leaving close to five lakh people surrounded by water. With the main crematorium grounds submerged, families are being forced to cremate their loved ones on the roads.

"We had never imagined we would have to face this. The water came in so fast we could only grab our children and run," said Phoolmati Devi, a resident of the Rasoolabad locality in Prayagraj. "We left everything behind—our ration, clothes, goats. Our home is now under waist-deep water."

Rajkumar Yadav, a farmer from Jhansi, said, "For the last three days, we have been living on the terrace of a neighbouring house. The government boats came only once. We are hungry, and there is no drinking water left."

In Varanasi, the Jeevi Manikarnika Ghat, which is central to Hindu last rites, is under water. All 84 ghats stand submerged, and nearly 1,000 temples lie

along the riverbanks are flooded. The Ganga is now just 1.50 metres below the danger mark, with fears mounting of a further rise. Siddheshwar Pandey, who came from Ghosior to cremate his 76-year-old mother at Manikarnika Ghat, was forced to perform her last rites in a narrow alley. "This is not how I wanted to say goodbye to my mother," he said, holding back tears.



■ incessant rains in Kerala caused minor mudslides and flooding of homes in Kozhikode district along with waterlogging of low-lying areas and rise in water levels of various rivers in other parts of the state on Thursday. In Kasaragod district, the water level of various rivers, including Uppala, Manjeswaram, Madhur and Puthige, rose due to the heavy rains, prompting authorities to warn people living on the banks of these rivers to be vigilant.

■ The ongoing monsoon season has claimed 109 human lives across Himachal Pradesh between June 20 and July 16, 2025. Of these, 64 deaths were directly linked to rain-related incidents, and 45 fatalities were reported in road accidents. This was stated in the latest cumulative report released by the State Disaster Management Authority (SDMA) of Himachal Pradesh.

■ The Meteorological Department has issued a warning for heavy rainfall in several parts of Rajasthan on Thursday and Friday, following the formation of a new weather system. The parts of the state recorded moderate to extremely heavy rainfall during the past 24 hours. Heavy rainfall disrupts life in Rajasthan; schoolchildren trapped, roads flooded.

SC frowns upon HC granting bail to Kannada actor Darshan

The Supreme Court on Thursday expressed its reservation over the Karnataka High Court's decision to grant bail to Kannada actor Darshan Thoogudeepa in the Remuska-wamy murder case.

A Bench of Justices J B Pardiwala and R Mahadevan said it was "not at all convinced" by the manner in which the high court exercised its discretion. The bench asked senior advocate Kapil Sibal, appearing for the actor, to give "good reasons" why it should not interfere with bail order.

Hands up in the air: Delhi court punishes 4 accused for contempt

A Delhi court directed four accused persons to stand in the court with their hands raised in the air for the entire day after finding them guilty of contempt of court.

Judicial magistrate Saurabh Goyal was hearing a 2018 complaint case, which was at

the stage of pre-charge evidence.

In an order dated July 15, he said, "Despite warning and calling the matter twice from 10 AM till 11:40 AM, the bail bonds were not furnished by the accused persons. For wanting the time of the court, which is in contempt of the order duly promulgated on the last date of hearing, the ac-

cused persons are hereby held guilty for contempt of court proceedings and are considered for the offence under Section 228 (intentional insult or obstruction to public servant sitting in judicial proceeding) of the IPC." The order continued, "They are directed to stand in the court with their hands straight in the air."

Day after Fadnavis' tongue-in-cheek 'offer', Uddhav meets CM along with Aaditya

Shiv Sena (UBT) head Uddhav Thackeray on Thursday met Maharashtra Chief Minister Devendra Fadnavis, the move coming a day after the latter's "come here" offer to his former ally set off political speculation in the state.

Thackeray met Fadnavis in the chamber of legislative council chairman Ram Shinde. During the meeting, which lasted for about half an hour, the former CM's son and Worli MLA Aaditya Thackeray was also present.

On Wednesday, speaking at the farewell function of leader of opposition in the

council Ambadas Danve, the CM, in a tongue-in-cheek remark, told Uddhav Thackeray that the BJP was not likely to join him in the opposition, but he can come over to the ruling side.

"Uddhav ji, there is no scope (for a change in government) till 2029. We do not have the scope to come to the

other (opposition's) side. You have the scope to come here, and it can be thought about. We can think about it differently," Fadnavis said.

The undivided Shiv Sena led by Thackeray parted ways with the longtime ally BJP after the 2019 assembly elections over a dispute on sharing the CM's post.

Annamalai appears in court in defamation case filed by DMK leader

Former Tamil Nadu BJP president K Annamalai appeared before a court here on Thursday in connection with a defamation case filed by DMK MP TR Baalu.

The XVth Metropolitan Magistrate, before whom Annamalai appeared, posted to August 28, further hearing of the case. In his complaint, Baalu had said that the "DMK files" released by Annamalai had malicious allegations against him.

Balu sought action against the TR leader for raising allegations without substantial evidence, which amounts to defamation and thus attracts relevant penal provisions.

Balu further said the defamatory statements were issued with a malicious intention to harm his reputation and defame him before the public.

The "DMK files" released by Annamalai on April 14, 2023, contained several vile and reckless statements about him that were per se false, defamatory and have scandalous imputations, according to Baalu. In a social media post, Annamalai claimed that Baalu did not appear before the Sadiqpur court "as usual."

BJP blasts Rahul's stealing charge at EC Scaffs at jail swipe on Assam CM

The Bharatiya Janata Party (BJP) on Thursday launched a blistering attack at the Leader of Opposition (LoP) in Lok Sabha Rahul Gandhi, over latter's charge of "election chori" at the Election Commission (EC) regarding the "SIR" exercise in Bihar and also sarcastic swipe at Assam Chief Minister Himanta Biswa Sarma at a public rally.

A couple of BJP spokespersons hit out at the Congress MP for taking potshots at the voters list "purgings" drive in Bihar, as part of Special Intensive Revision (SIR) and accused him of belittling and demeaning the poll named with vague and outlandish claims.

Taking strong objection to his "prison prophecy" for the Assam CM, they called out



Gandhi's "brazenness" of naming and shaming others while himself being an accused, currently on bail.

BJP spokesperson Tarun Chugh said that Congress has launched him multiple times, but the party as well as his "yuvraj" failed repeatedly in multiple elections. Still, he remains defiant and tries to spread disorder with irresponsible and reckless remarks.

He further said that the Congress leader as well as the party was surrounded by negativity, frustration and depression and hence were making such baseless charges.

TV ACTRESS ALLEGES MOLESTATION, THREAT OF ACID ATTACK IN KOLKATA

A police case was registered after a television actress alleged that she was molested and threatened with an acid attack in the Jadavpur area of south Kolkata.

However, the accused have filed a counter-complaint, alleging that they were assaulted by the actress's friends.

Although it was earlier reported that two persons had been arrested, police later clarified that no arrests have been made so far. In light of the counter-complaint, both parties have been summoned to the police station, where their statements are being recorded as part of the ongoing investigation.

The incident reportedly took place around 3:30 am on Wednesday.

According to the actress, she was returning home from a shoot when she stopped near the Krishna Glass Factory along with four friends for tea. She claimed that two young men, apparently in an inebriated state, arrived in a car and began hurling obscene and vulgar abuses at her without any provocation.
